



A FUNDRAISER AT RINK SIDE.... WHAT A GREAT IDEA...RAIN OR SHINE!

Since opening in 1999, Rink Side has proudly supported organizations with our “Caring & Sharing” programs which include our fundraising programs. When evaluating partners, ideal organizations are those that strengthen families, promote a safe, nurturing environment for children and youth, and emphasize student academic achievement.

Rink Side’s donations are not intended to be used by individuals or groups collecting personal or corporate profit, or causes that are in contrast to our family based values.

How Rink Side’s Fundraisers Work:

- Each organization is reserved a day and date at Rink Side. The organization may only select one day. Fundraisers will be scheduled based on availability at Rink Side. Not available on most holidays.
- Each organization will be emailed a PDF version of a flyer (2 per page) with detachable tickets. It is the responsibility of the organization to email and/or print the flyers to distribute to their supporters. For a successful fundraiser, we recommend distributing at least 500 flyers, so the organization will need to print 250 copies and cut each page into 2 flyers.
- All flyers will have detachable tickets, which must be turned in when making purchases on the reserved day. Tickets may be turned in for laser tag (single games only-double and triple discounts will not apply), ice skating admission & rental during that day’s public sessions, Rink Side Game Cards (which can be used for Laser Tag, Tornado rides, playing games), and purchases at the restaurant counter. Tickets cannot be used for purchasing gift cards, Birthday Party or Group Discount Packages.. We will attach the flyer ticket to a copy of the receipt and the organization will receive 20% of sales that have flyer tickets attached to the receipt on the reserved day.
- Rink Side also recommends selling raffle tickets for donated prizes. Rink Side will also donate a raffle prize. The organization must acquire any other prizes and the raffle tickets to be sold. A table can be supplied by Rink Side to display the prizes.
- Upon Rink Side’s approval, an area to display selected materials describing the organization can be arranged.

Fundraiser Rules:

- Dates must be requested at least three weeks in advance. Due to limited availability, schedule as far in advance as possible.
- Guests must have a flyer to have their sale counted in the total tally.
- Seating can be guaranteed for large parties based on availability. Encourage friends and family to visit Rink Side throughout the day.
- Organizations cannot distribute flyers on premises of Rink Side (this includes our parking lot). This must be communicated by the organization to all persons distributing flyers. Distributing flyers in this manner will result in the forfeiture of your organization’s entire donation.
- You must receive approval from ANY private property owner if you wish to distribute/solicit flyers on premises (i.e. placing flyers on cars, handing out at shopping centers, mailboxes, etc.). The organization will be responsible for paying any littering or postal fines accrued if this rule is violated. Rink Side strongly discourages this method of flyer distribution.
- Organizations bringing in over \$1000 in sales will be permitted to schedule an additional fundraiser after 90 days of the initial fundraiser date based on availability. There is a minimum of \$200 to achieve the 20% payout.

Rink Side Provides:

- The great atmosphere that we always offer for the organization’s fans, friends and family to enjoy!
- An electronic version (PDF) of a flyer with detachable ticket, via email.

The Organization Provides:

- Distribution of 500 flyers (not on Rink Side premises).
- Encouragement and enthusiasm to visit and make purchases at Rink Side on the selected date!
- Federal Employer Identification Number (##-####-####) of organization. Rink Side will not be able to write a check without it!
